



## STATEMENT OF RESPONSIBILITY AND RELEASE OF LIABILITY

I, the undersigned, am the traveler or the person arranging the travel for the travelers mentioned below. I and/or the people I am arranging the travel for, desire to travel for pilgrimage (Hajj) in the year of 2022 with 1652262 Ontario Inc. O/S Ikhlas Hajj & Umrah Services . In consideration of being allowed to travel for pilgrimage (Hajj) with Ikhlas Hajj & Umrah Services , I hereby agree as follows:

- 1) I and/or all the travelers mentioned below understand that only travelers under the age of 65 (at the return date of your package) will be issued visas and allowed to travel to the Kingdom of Saudi Arabia for pilgrimage (Hajj).
- 2) I and/or all the travelers mentioned below understand that only travelers who received the first, second, and the booster(third) shots against COVID-19 from one of the following companies, will be issued visas and allowed to travel to the Kingdom of Saudi Arabia for pilgrimage (Hajj). **(Pfizer/BioNTech – Moderna – Oxford/AstraZeneca – Janssen (Johnson & Johnson))**.
- 3) I and/or all the travelers mentioned below understand that any COVID-19 vaccine other than the mentioned above, will not be acceptable and will result in being denied to travel to the Kingdom of Saudi Arabia for pilgrimage (Hajj).
- 4) I and/or all the travelers mentioned below understand that it is my sole responsibility to have and submit a negative COVID-19 PCR test result from a test performed within 72 hours of the departure date from Canada to the Kingdom of Saudi Arabia.
- 5) I and/or all the travelers mentioned below understand that if I/we do not have a negative COVID-19 PCR test result or have a positive COVID-19 PCR test result from a test performed within 72 hours of the departure date from Canada to the Kingdom of Saudi Arabia, I/we will be denied traveling and will lose all the money paid to 1652262 Ontario Inc. O/S Ikhlas Hajj & Umrah Services towards my pilgrimage (Hajj) package.





- 6) I and/or all the travelers mentioned below understand that if Canada require a negative COVID-19 PCR test result on the way back from the Kingdom of Saudi Arabia, it will be my/our sole responsibility financially to undertake a COVID-19 PCR test in the Kingdom of Saudi Arabia.
- 7) I and/or all the travelers mentioned below understand that if my/our COVID-19 PCR test is positive, then I/we will not be able to travel from Saudi Arabia. In such event I/we understand that any financial responsibility occurs from extending my/our stay at the hotel, performing another COVID-19 PCR test, food, and transportation will be my/our sole responsibility.

**I and/or all the travelers mentioned below agree that by NOT binding to every part of this 2 pages statement, I am/we are giving up the right to travel for pilgrimage (Hajj) with 1652262 Ontario Inc. O/S Ikhlas Hajj & Umrah Services AND will be subject to 100% cancellation penalty.**





I and/or all the travelers mentioned below release and forever discharge 1652262 Ontario Inc. O/S Ikhlas Hajj & Umrah Services , its owners, directors, officers, employees, agents, subagents, assigns, legal representatives, and successors from all manner of actions, causes of action, debts, accounts, bonds, contracts, claims, and demands for or by reason of not being able to travel or obtain pilgrimage (Hajj) visa, including any financial loss due to a positive COVID-19 PCR test result in Canada or in Saudi Arabia, which has been or may be sustained as a consequence of traveling to the Kingdom of Saudi Arabia to perform pilgrimage (Hajj), and notwithstanding that such damage, loss or illness may have been caused solely or partly by the negligence of 1652262 Ontario Inc. O/S Ikhlas Hajj & Umrah Services.

This Statement of responsibility and release of liability will be governed by and construed in accordance with the laws of the Province of Ontario.
